**2016 SHEEP TAGGING REQUIREMENTS**

**LAMBS**

**(FOR SLAUGHTER BEFORE 12 MONTHS OF AGE)**

Lambs born from January 2016 onwards will require a single electronic eartag OR two eartags, one of which must be electronic

**BREEDING SHEEP**

Breeding sheep born from January 2015 onwards will require two eartags, One of which must be electronic, as currently.

**GRAZING/CULL EWES**

From January 2015 onwards we will only be able to sell ewes which have a pair of tags with the same number, One of which must be electronic, to the open market. Ewes presented for sale with manual eartags will only be permitted to be sold to an abattoir holding number, ie to a slaughterhouse purchaser only.

**FOOD CHAIN INFORMATION FOR SHEEP AND GOATS**

**WITHDRAWAL PERIODS:** Stock must not be offered for sale if they have not completed the specified withdrawal period from medical treatments, unless a statement is made to the contrary (**see declaration (g) overleaf**).

Vendors of any sheep or goats which could be slaughtered for human consumption within 3 months of the date of sale are required to complete the **Food Chain Information Declaration (g)** overleaf. A Food Chain Information document is available for inspection on the Greenslade Taylor Hunt website or at the market office.
