Pigs condemned at slaughter, having been rejected by the MHS as unfit for human consumption, will not be paid for. Greenslade Taylor Hunt, as Auctioneers at Sedgemoor Auction Centre, act as principals in all financial transactions. Sale proceeds are not paid into a client bank account and consequently the RICS Client Money Protection Scheme (CMPS) will not apply to protect the Vendor.

IDENTIFICATION REQUIREMENTS FOR PIGS
ATTENDING SEDGEMOOR MARKET

When pigs arrive at market they must have either:-

- (a) An eartag with the letters “UK” followed by the herdmark of the holding from which it is being moved. If pigs are not homebred they will require an additional tag for holding of departure.**

- (b) A tattoo showing that herdmark (with or without the letters “UK”)**

A tattoo must be applied either by tattoo forceps, in which case it must be on an ear, or by slap-marking equipment, in which case it must be on each shoulder and must, in either case, be easy to read.

The above legislation does allow a vendor of a pig that is not correctly identified when it arrives at Sedgemoor Market, to correct the identification so that it is identified with the herdmark of the holding from which it arrived. However, if the Vendor does not do so the pig may only be returned to the holding from which it came.
