Rams are to be sold as warranted to be capable of getting stock. All stock will be sold in pounds. For Pedigree registered stock, a copy of their pedigree is to be enclosed with this entry form. Commission will be charged at 5%. Normal tolls apply of 55p per Breeding Ewe or Ewe Lamb and £2.50 per Breeding Ram.

PLEASE NOTE ALL SHEEP MUST BE ACCOMPANIED BY FORM AML1**FOOD CHAIN INFORMATION FOR SHEEP AND GOATS**

WITHDRAWAL PERIODS: Stock must not be offered for sale if they have not completed the specified withdrawal period from medical treatments, unless a statement is made to the contrary (**see declaration (g) overleaf**). Vendors of sheep or goats which could be slaughtered for human consumption within 3 months of the date of sale are required to complete the **Food Chain Information Declaration (g)** overleaf. A Food Chain Information document is available for inspection on the Greenslade Taylor Hunt website or at the market office.
